### Asheville's public safety reality is stuck on broken...

It's been roughly three years since Asheville's City Council unilaterally destroyed public safety in WNC's central city.

We make that observation for three distinct reasons-

- 1) This elected body effectively controls the funding and operating philosophy of Asheville's police department by hiring and indirectly controlling the city's chief administrator who, in turn, controls our police chief and thus the morale of our officers.
- 2) This elected body (homogeneously comprised of seven females each of whom has a voting record that definitively would be described as liberal and reflective of the platform, policies, and practices of today's Democratic Party) has a long history of antagonism toward Asheville's public safety agency while being permissive, selective and inconsistent in the enforcement of city, state, and federal law.
- 3) This elected body, during a time of public discord and protest, indulged a series of activities that evolved into large group riots characterized by violence, abuse of public property, vandalism of private property, takeover of public streets and highways, and other forms of illegal

**Buncombe Schools Redistricting Plan** 

In the dynamic and often contentious arena of Buncombe County's school board redistricting, the situation is as complex as it is critical. Central to this debate is the issue of fair representation. Our current at-large voting system for school board members allows every county voter to vote for representatives of each district. It's a stark contrast to how we elect our County Commissioners, where, for example, voters in Commissioner District 1 have no say in whether Terri Wells gets re-elected in District 2. Each district votes independently for its representative. The current approach to electing School Board members is akin to playing a basketball game where one team has all the players – a setup that leaves conservative voices struggling to be heard.

Having our values and perspectives adequately represented becomes daunting when the majority leans in a different direction. The result is a school board that may not fully align with or even understand the concerns of conservative constituents.

On January 11, the Buncombe County Schools Board, perhaps grudgingly, convened to mull over redistricting options. This was in response to HOUSE BILL 66 (Boards of Education Elections), which aims to reshape the current electoral process. Consultants laid out three draft options, each considering factors like high school enrollment districts, incumbent placements, and "communities of interest".

Amidst this, Amy Churchill, Vice-Chair and Roberson District Representative, has emerged as a controversial figure. Far from being the conservative torchbearer, she's faced criticism from local Republicans for her vocal opposition to HB66, referring to it as a "partisan" bill. Her support for student masking during the pandemic, perceived endorsement of CRT-

## Covid Relief Funds Left Unspent

In Buncombe County, an intriguing situation is unfolding – unspent COVID relief funds totaling over \$400,000 have been left untouched. This issue is significant for conservatives and even non-conservative taxpayers alike, raising questions about fiscal responsibility and prudent financial management. Furthermore, the absence of an agenda item for a required public hearing and a vote to close the program at the January 16 regular meeting has ignited concerns. Is there a rush to find some way to extend the deadline (June 2023) and discover some way to spend this money without clear and prudent planning?



#### The Unspent Funds Challenge

In August 2021, Buncombe County received \$900,000 in funds through HUD's CDBG Coronavirus Program, a part of the CARES Act. A portion of these funds was used to assist those impacted by the pandemic with mortgage and utility aid.

However, today, an unencumbered balance of \$404,212 remained at the program's conclusion in June 2023. Stoney Blevins (the county's Health & Human Services director), his staff, and County Manager Avril Pinder have recommended closing the CDBG Coronavirus grant program. Commissioner Terri Wells asked during the January 2 regular meeting, "Is there any way that they would allow us to continue with it since there was that delay in them getting the funds to us?"

Blevins responded, "We actually explored that with them, and they were somewhat open to that. The challenge that we'll see at this point is the grant is so COVID-specific that we would have to tie assistance back to being caused by the pandemic. And at this point, we're so far removed from the public health emergency's end that we believe it will be almost impossible to find that tie back at this point in time."

Wells lamented, "It's just such a shame when there's that money that feels like we could have put to good use somehow to help the community."

## The Conservative Perspective on Fiscal Responsibility

As a conservative, I hold a deep-seated belief in responsible fiscal management, ensuring that taxpayer dollars are spent judiciously. When unspent funds come to the forefront, it's imperative to consider the ramifications of hasty spending decisions.

#### A Desperation for Spending?

The absence of an agenda item for a public hearing and vote on the program closure at the January 16 meeting raises questions. Is there an urgency to expend these funds without a comprehensive plan? Are our elected representatives hastily searching for ways to use these funds, potentially overlooking the best interests of taxpayers? Didn't they understand that the grant period ended over six months ago?

Update: First Tuesday emailed the commissioners about this topic. Terri Wells replied that the public hearing has been scheduled for Februay 6.

#### A Cautionary Note for Taxpayers

Vigilance is key for conservatives regarding government spending. Unspent funds should not be seen as an opportunity for unchecked spending.

#### **Transparency and Accountability**

Conservatives ardently champion transparency and accountability in governmental actions. Taxpayers must have a crystal-clear understanding of how their money is utilized, with decisions made in their best interests.

The dialogue in Buncombe County underscores that fiscal responsibility is a collective endeavor. It commences at the local level but resonates nationally.

activity. Simultaneously, this elected body threatened our police force with legal action, criticized their performance with arbitrary and presumptive accusations and commentary, and otherwise created a political climate that antagonized and undermined the security and enthusiasm of our community's primary public safety agency.

The results landed on a mass exodus of existing officers and an on-going serious

impairment of APD's ability to recruit new trainees. This echo has endured far longer than the broken windows, painted streets, and enthusiasm of those who participated in our community's series of politically/socially/personally (it's a great way to act out one's anger, break things, and clinch a date) motivated riots.

Most of the Asheville council members – including the Mayor – who pulled the plug on APD are still around. So are the consequences.

Most liberally governed cities in America have suffered a severe loss of police officers in recent years – few can approach the impact experienced in Asheville. On an average day in 2023, our police patrol presence is about half of what it was before APD's mission was assassinated by our elected officials and the frivolity of a large number of area residents with a strong attachment to enthusiasm and an indifference to the law of unintended consequence.

The result is that many crimes are ignored for a lack of manpower and broad officer hesitancy. Crimes are routinely unreported and our drug culture and the lawless have been unleashed.

Predictably, our politicians and supportive media outlets are blaming demographics, money, and "our city's unique character and diversity" for a worsening public safety reality. We see all of these as decoy issues.

The truth can be narrowed down to on or about the time our police chief, city administrators, and elected officials kneeled down – literally and figuratively – in the face of the shrill claims, accusations, and demands of the BLM movement and other social change bodies enamored with the idea of no enforcement of the law over the more challenging mission of good enforcement of the law.

The boards are still up on Asheville's shattered public safety widow – and will be so for a long time to come...

## Transparency Needed: Buncombe County Salaries

Upon reviewing the agenda for the January 2nd Buncombe County Commissioners meeting, a particular item stood out: "Consideration of Board of Elections Director Compensation". I hoped to see fiscal efficiency commendations, enhanced voter services, or increased election integrity. Instead, the proposal suggested a salary increase for the director simply because she has remained in position, a rationale seemingly devoid of performance metrics. This approach to managing public resources surely merits scrutiny.

Sharon Burke, Buncombe County HR Director, cited a comparative salary review and noted the county's lack of a performance-based compensation program. Yet, the reported and proposed salaries differ significantly, indicating a lack of clarity and accountability in these financial decisions.

We must understand and challenge the processes behind such significant financial decisions. Why is there no performance-based justification for Buncombe County salary increases? This policy needs some open discussion. Is this something resulting from a DEI initiative?

A transparent and rigorous approach is necessary to ensure salary adjustments are rightfully earned and clearly explained. Nevertheless, Commissioner Whitesides (District 1) was tired of discussing this topic and moved to approve the \$115,000 salary - "...we aren't talking about a lot of money. I think let's go ahead and approve it and move on." Jasmine Beach-Ferrara(District 2) seconded, and the Commissioners voted unanimously to grant the meritless pay raise during their January 16 meeting. Meritless salary increases are no big deal to these stewards of public funds.

Your engagement is crucial in shaping a more accountable and efficient local government. Speak to your representatives and Encourage the adoption of a performance-based pay structure.
